If you receive a refund you are not entitled to, you must pay it back when Bromsgrove School Enterprise asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Membership Terms and Conditions

YOUR ATTENTION IS DRAWN IN PARTICULAR TO THE PARAGRAPHS HIGHLIGHTED IN BOLD.

GENERAL

1. These Terms and Conditions apply to your membership of the Bromsgrove School Sports Centre.
2. **Please read these Terms and Conditions carefully and let us know if there is anything which you do not understand or which you are unsure about.**
3. This agreement is between Bromsgrove School Enterprises Limited and you. "You" means the person/s named on the application form. Bromsgrove School Sports Centre is a trading name of Bromsgrove School Enterprises Limited and in these Terms and Conditions, "Bromsgrove School Sports Centre" means Bromsgrove School Enterprises Limited.
4. Bromsgrove School Sports Centre may vary these Terms and Conditions where necessary in order to comply with a change in the law. Bromsgrove School Sports Centre will give you 40 days' notice of any such change. If you do not accept the change, you may cancel your membership (in which case, Bromsgrove School Sports Centre will refund the unused proportion of your membership fee (eg 50% will be refunded if you pay annually and you are 6 months into your membership)).
5. You must tell us promptly if any information you provide becomes out of date or is no longer correct. This includes, for example, your contact details or medical information which may be relevant to your use of the facilities.

MEMBERSHIP

6. You can only hold a membership package of Bromsgrove School Sports Centre if you are aged 16 or over.
7. Bromsgrove School Sports Centre reserves the right to reject any application or withdraw any membership in the event of a serious failure to comply with these Terms and Conditions. A "serious failure" means:
 - any failure by you to pay your membership fee by the due date for payment;
 - a repeated breach of these Terms and Conditions by you;
 - any breach of these Terms and Conditions which could endanger your health and safety or the health and safety of someone else.
8. You will only be permitted to use the facilities if your membership is current and fully paid up.

FEES

9. Membership fees are payable in advance either by monthly Direct Debit or annually by cash, debit, credit card or cheque (payable to "Bromsgrove School Enterprises Limited"). An initial payment covering the period from joining up to the first Direct Debit due date may be also be requested and must be made before access is allowed to the Bromsgrove School Sports Centre facilities.
10. Bromsgrove School Sports Centre reserves the right to vary membership fees; you will be given one calendar months' notice of any fee increase. You may cancel your membership if you do not accept the increase (in which case your membership fee will be refunded proportionally as described in paragraph 4 above).

MEMBERSHIP CARDS

11. All membership cards remain the property of Bromsgrove School Sports Centre and on cancellation of membership must be returned to Bromsgrove School Sports Centre.
12. You must present your membership card to reception on every visit before using the facilities. Any loss of membership cards must be reported to Bromsgrove School Sports Centre immediately. Bromsgrove School Sports Centre reserves the right to make a reasonable charge for replacement cards.
13. You must not allow anyone else to use your membership card. Cards being used in this way may result in your membership being cancelled without notice. No refund for fees paid in advance will be given under these circumstances.

USE OF EQUIPMENT / FACILITIES

14. You must undertake an induction and complete a Physical Activity Readiness Questionnaire declaring any known medical conditions before being allowed access to the Fitness Suite. You must let Bromsgrove School Sports Centre know immediately should there be any change to your health, or should you develop any new medical conditions, which could affect your ability to use the health club facilities safely.
15. You must not use any equipment or facilities unless you are satisfied that you are competent to do so safely and properly. You must check with Bromsgrove School Sports Centre staff if you are in any doubt.
16. You must use all equipment and facilities safely and properly and take care to safeguard your own and other users' health and safety.
17. You must follow any relevant guidance or instructions on any equipment signs or notices.
18. Admission is subject to the facility operating within safe capacities and during times of peak demand Bromsgrove School Sports Centre staff reserve the right to control activity session times.
19. Bromsgrove School Sports Centre reserves the right to make reasonable changes to members' facility access times and will provide reasonable notice of changes to members.
20. Where a membership qualifies for free racket sports only one court, per member, per hour is permitted to be booked.

CANCELLATIONS

21. Unless paragraph 25 below applies, a minimum of at least one month's notice in writing is required if you wish to cancel your membership.
22. From the 1st June 2013, unless paragraph 24 below applies, there is a minimum 3 month membership term on all monthly memberships (not casual). 1 months notice is required for the termination of monthly memberships. This can be given at any time so long as the termination date is greater than 3 months from the start date.
23. Bromsgrove School Sports Centre reserves the right to cancel your membership for any reason by giving you at least one month's prior written notice.
24. **Members paying annually who wish to cancel before their annual renewal date will not be given any refund.**
25. You may cancel your membership provided that you tell us within seven days starting the day after you join.

LIABILITY

26. **Subject to paragraph 28 below, Bromsgrove School Sports Centre does not have any liability for any items (such as clothes, money or sport equipment) brought onto Bromsgrove School Sports Centre premises except where Bromsgrove School Sports Centre staff agree to look after them or they are stored in a locker provided by Bromsgrove School Sports Centre in accordance with Bromsgrove School Sports Centre's instructions.**
27. **The total value of any items brought onto our premises by you must not exceed £1,000 (including any sports equipment).**
28. **Subject to paragraph 28 below, Bromsgrove School Sports Centre does not have any liability for any loss (including loss of personal possessions, injury or death) to the extent that the loss was caused by you failing to comply with these Terms and Conditions. This means, for example, Bromsgrove School Sports Centre will not be liable if you injured yourself because you failed to comply with instructions given by Bromsgrove School Sports Centre staff on how to use equipment safely.**
29. **Subject to paragraph 28 below, Bromsgrove School Sports Centre does not have any liability for any loss (including loss of personal possessions, injury or death) to the extent that the loss was caused by a third party (such as another member). This does not apply if the third party causes you a loss because of Bromsgrove School Sports Centre's negligence.**
30. **Regardless of anything else in these Terms and Conditions, Bromsgrove School Sports Centre does not exclude or limit in any way its liability for:**
 - death or personal injury caused by its negligence;
 - fraud or fraudulent misrepresentation;
 - any other matter for which it would be illegal or unlawful for us to exclude or attempt to exclude our liability.

CIRCUMSTANCES BEYOND BROMSGROVE SCHOOL SPORTS CENTRE'S CONTROL

31. Occasionally Bromsgrove School Sports Centre may have to close some, or all, of the facilities due to circumstances beyond Bromsgrove School Sports Centre's control. "Circumstances beyond our control" means anything which Bromsgrove School Sports Centre could not prevent by taking reasonable precautions such as an outbreak of swine flu, extreme adverse weather conditions or industrial action. Should this happen, then Bromsgrove School Sports Centre will not be in breach of these Terms and Conditions if you are unable to use our facilities. Please note that Bromsgrove School Sports Centre is part of Bromsgrove School and is subject to unavoidable closures as part of the normal school timetable. These closures have been calculated within the price of your membership and as such Bromsgrove School Sports Centre will not be in breach of these Terms and Conditions if you are unable to use our facilities.

DATA PROTECTION

32. When you complete the application form, you will be providing personal information about you and additional family members (if any). For example, you will be providing your contact details and information about your reasons for joining. Bromsgrove School Sports Centre may also obtain personal information about you during the course of your membership - for example, if you tell Bromsgrove School Sports Centre that you have a medical condition which affects what activities you do.
33. Bromsgrove School Sports Centre will only use this personal information for the following purposes:
 - to administer your membership. For example, Bromsgrove School Sports Centre may keep a record of your preferences to enable it to deliver a better service and Bromsgrove School Sports Centre may need to contact your if, for example, you have not paid your membership fee;
 - to enable us to improve the services Bromsgrove School Sports Centre offers to members (including you); and
 - to help us comply with our legal obligations (for example, Bromsgrove School Sports Centre may need to keep a record for health and safety reasons if you hurt yourself).
34. Bromsgrove School Sports Centre may share the personal information with Bromsgrove School as the School is responsible for Bromsgrove School Sports Centre's accounting and processes membership applications.
35. Bromsgrove School Sports Centre and / or Bromsgrove School may send you information about products and services which may be of interest to you as set out on the application form.
36. We do not sell your personal information to third parties.
